### PRESIDENT'S REPORT

Dear Members.

It is with great pleasure that I welcome members to the 50th Annual General meeting of The Australian Davis Cup Tennis Foundation and in doing so present to you for consideration and adoption the Annual Report of the Foundation incorporating the audited financial statements as at 30th June 2021.

As we are all aware the Covid-19 pandemic has intruded on our lives far more than we could ever have expected, it has changed the way we live, our daily routines and our schedules look to be forever altered. This upheaval meant the unfortunate cancellation of the Davis Cup competition for 2020, the first time since the end of World War 2 in 1945.

It goes with saying that it has been a difficult period for the Foundation, the inability to meet in person and travel to events has meant a slight decrease in our membership numbers. However, we have managed to stay financially stable throughout and look forward to growing our membership as we slowly start getting our members back together via tournaments and social functions in the coming year. In particular I look forward to welcoming everyone to our 50 years Anniversary Celebration event once Government restrictions allow us to be able to host all those Members that wish to attend.

In all the uncertainty we have been fortunate to still have had other key events played throughout the year and I would like to congratulate Craig Tiley and all at Tennis Australia on the remarkable effort of staging the Australian Open and summer of tennis in 2021. With limited spectators and a lockdown during the event, through broadcast we were able to enjoy quality tennis. It cannot be underestimated what an incredible feat it was to make this happen.

The Australian Open saw steady results for Alex De Minaur and Nick Kyrgios. both reaching the third round of singles. Matt Ebden had an excellent tournament in the doubles event being a runner up in the mixed with Sam Stosur and semi-finalist with JP Smith in the men's doubles.

The ATP Cup team event played at Melbourne Park saw Russia defeat Spain in the final. Australia was placed in Group B with Spain and Greece. Australia finished second in the group and failed to make the semi-finals with an opening 3-0 loss to Spain and a 2-1 victory over Greece.

It would be remiss not acknowledge Ash Barty and her magnificent performance in winning the Wimbledon Ladies Singles Championship, her play and demeanour a throwback to the greats of our game and a joy to watch.

The Olympic Games postponed from 2020 took place in Tokyo and we congratulate John Peers who alongside Ash Barty won a bronze medal for Australia in the mixed doubles. There was disappointment for Australia's number one player Alex De Minaur as he contracted covid 19 days before

leaving for Tokyo. His replacement was Max Purcell who took advantage of the opportunity with a big win over Canadian Felix Auger Aliassime before losing to Dominic Koepfer of Germany.

As we edge closer to travel restrictions returning to normal it remains a goal as part of the ADCTF philosophy to support the up-and-coming new generation by helping to provide opportunities to participate in tournaments domestically and travel overseas to gain valuable experience. This is more important than ever for our junior players as they have suffered enormously in gaining the experience necessary to compete on a world stage by being stranded in Australia during this pandemic. If they are to succeed in their individual pursuits and also in representing Australia, they need our support more than ever.

During the period under review the tennis family was saddened to hear of the passing of Wayne Reid OBE, aged 83, a former tennis player and sports administrator who was President of the Lawn Tennis Association of Australia from 1969 to 1977 and it was during this period in 1971 he was involved in the forming of The Australian Davis Cup Tennis Foundation.

Finally, I would like to acknowledge all and share my appreciation to the Board of Directors for the significant contributions and guidance this past year, in particular Neale Fraser who has been a wonderful mentor for me in the position as President in these difficult times. But also, to Judy Pullybank and Robert Parker our Administrators, Robert Jamieson the Honorary Treasurer and Mary Klestadt in production of our eNews, web maintenance and communications. The time and effort given is appreciated, not just by me but all in the Foundation.

### THE DAVIS CUP FORMAT

In 2020, 142 nations entered Davis Cup, making it the world's largest annual international team competition in sport.

Due to the Covid19 virus the 2020 competition was suspended and postponed until 2021 with the finals taking place in Spain 23-29 November 2021. The Finals will feature the 18 teams qualified for 2020 -12 qualifiers, four semi-finalists from 2019 and two wild card nations. The 18 teams will compete in six round-robin groups of three teams. The six group winners plus the two second-placed teams with the best records based on percentage of sets won (followed by games won), will qualify for the quarter-finals.

The Davis Cup champions will be crowned after the completion of the knockout phase.

The two teams with the worst record after the round-robin phase of the Finals will be relegated to the Zone Group competition the following year. The 12 teams that finish in 5th to 16th positions will compete in the Davis Cup Qualifiers the following year.

The 2020 Davis Cup Qualifiers took place on a home-and-away basis on 6-7 March 2020, with 24 nations competing for the 12 qualifying places in the Davis Cup Finals.

The 12 losing nations from the Davis Cup Qualifiers and all other entered nations will contest the Zone Group competition in 2021. These nations will be placed in regional groups based on their Davis Cup Nations Ranking as at February 2021.

Group I will be divided into six Europe/Africa ties, three Americas ties and three Asia/Oceania ties. All Group I ties will be played on a homeand-away basis in September. The 12 Group I winners will contest the Davis Cup Qualifiers in the following year. The 12 Group I losers will not automatically be relegated but will contest the Zone Group competition the following year.

Group II will be divided into six Europe/Africa ties, three Americas ties and three Asia/Oceania ties and will be played on a home-and-away basis in either April or September. There will be no automatic promotion or relegation from Zone Group II. Week-long round-robin events will be

held in the three regions. The venues will be confirmed once the list of participating nations and hosts have been finalised.

#### **Finals**

Ties at the Finals will consist of two singles matches and one doubles match. All matches are the best of three tiebreak sets.

### Davis Cup Qualifiers, Groups I and II

Ties in the Davis Cup Qualifiers and in Groups I and II will consist of five matches played over two days: two singles on day one, followed by the doubles and two reverse singles on day two. All matches are the best of the three tiebreak sets

### Groups III and IV

All ties will consist of two singles matches and one doubles match. All matches are the best of three tiebreak sets

#### **ATP CUP 2021**

The 2021 ATP Cup was the second edition of the ATP Cup, an international outdoor hard court men's tennis tournament held by the Association of Tennis Professionals (ATP). It was held with 12 teams at Melbourne Park in Australia. from 2 to 7 February 2021.

It was originally supposed to take place with 24 teams in Brisbane, Perth and Sydney from 1 to 10 January 2021, but was changed due to the impact of the COVID-19 pandemic.

Team Serbia was the defending champion, but got eliminated in the group stage. Team Russia won the tournament. defeating Italy 2-0 in the final.

Australia played in the Group B qualifying group but failed to qualify for the finals after losing to Spain.

### NOTES TO AND FORMING PART OF THE ACCOUNTS FOR THE YEAR ENDED 30th JUNE, 2021

#### NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of preparation

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards, Australian Accounting Interpretations, other authoritative pronouncements of the Australian Accounting Standards Board and the Corporations Act 2001. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated.

The financial statements have been prepared on an accruals basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

#### (a) REVENUE AND EXPENDITURE

The Company recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the entity and specific criteria have been met for each of the Company's activities as discussed below.

Generally the timing of the payment for sale of goods and rendering of services corresponds closely to the timing of satisfaction of the performance obligations. however where there is a difference, it will result in the recognition of a receivable, contract asset or contract liability.

Revenue is recognised on a basis that reflects the transfer of promised goods or services to customers at an amount that reflects the consideration the Company expects to receive in exchange for those goods or services. Donations and beguests are recognised as revenue when received.

Interest revenue is recognised when it becomes receivable on a proportional basis taking into account the interest rates applicable to the financial assets. Other income is recognised on an accruals basis when performance obligations are satisfied. All revenue is stated net of the amount of goods and services tax (GST).

### (b) INCOME TAX

No provision for income tax has been raised as the entity is exempt from income tax under Div 50 of the Income Tax Assessment Act 1997.

#### (c) CASH AND CASH EQUIVALENTS

Cash and cash equivalents include cash on hand, deposits held at call with banks and other short-term highly liquid investments with original maturities of twelve months or less.

### (d) GOODS AND SERVICES TAX (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

#### (e) ACCOUNTS PAYABLE AND OTHER PAYABLES

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the company during the reporting period which remain unpaid. The balance is recognised as a current liability.

#### (f) FINANCIAL ASSETS

All recognised financial assets are measured in their entirety at fair value.

#### Classification

On initial recognition, the Company classifies its financial assets into the following category, those measured at:

fair value through profit or loss – FVTPL

Financial assets are not reclassified subsequent to their initial recognition unless the Company changes its business model for managing financial assets.

Financial assets through profit or loss

All financial assets not classified as measured at amortised cost or fair value through other comprehensive income as described above are measured at FVTPL.

Net gains or losses, including any interest or dividend income are recognised in profit or loss.

The Company's financial assets measured at FVTPL comprise listed investments over which they do not have significant influence nor control.

### (g) EMPLOYEE BENEFITS

Provision is made for the company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

Contributions are made by the Company to an employee superannuation fund and are charged as expenses when incurred.

(h) ADOPTION OF NEW AND REVISED ACCOUNTING STANDARDS

During the current year, the Company adopted all of the new and revised Australian Accounting Standards and Interpretations applicable to its operations which became mandatory. The adoption of these Standards has not had a significant impact on the recognition, measurement and disclosure of transactions.

## (i) NEW ACCOUNTING STANDARDS FOR APPLICATION IN FUTURE PERIODS

The AASB has issued new and amended Accounting Standards and Interpretations that have mandatory application dates for future reporting periods. The company has decided against early adoption of these Standards but does not expect the adoption of these standards to have any significant impact on the reported position or performance of the Company.

#### **NOTE 2: RELATED PARTY TRANSACTIONS**

No transactions between related parties were conducted save for services provided by directors at no fee.

#### NOTE 3 EVENTS OCCURRING AFTER THE REPORTING DATE

The financial report was authorised for issue on 13 September 2021 by the Directors.

The World Health Organisation announced that the coronavirus disease (COVID-19) had become a pandemic on 11 March 2020. The timing, extent of the impact and recovery from COVID-19 on Company is unknown at this stage. However, the full impact of the COVID-19 outbreak continues to evolve as at the date of this report. As such, the Company is unable to estimate the effects of the COVID-19 outbreak on the Company's financial position, liquidity and operations in the 2022 financial year.
