PRESIDENT'S REPORT

Dear Members,

It is with great pleasure that I welcome members to the 52nd Annual General Meeting of The Australian Davis Cup Tennis Foundation and in doing so present to you for consideration and adoption the Annual Report of the Foundation incorporating the audited financial statements as at 30th June 2023.

Having already qualified in March 2022 to compete in the final 16 stage of the Davis Cup competition, Australia was grouped with Belgium, France and Germany to play in Hamburg in September 2022. The top two teams in each of four groups would qualify for the knock out Final 8 stage in November. Australia finished in 2nd spot with wins over Belgium and France but went down to the group winners Germany. The team of Alex De Minaur, Jason Kubler, Thanasi Kokkinakis, Matt Ebden and Max Purcell did a fantastic job to get the result we needed. The knock out Final stage of the competition was played in Malaga, Spain from the 22nd to 27th November. The Australian team was similar to the one in September although Matt Thomson replaced an injured Jason Kubler. The team did the Country proud with a quarter final win over Netherlands, a semi final win over Croatia, only to be defeated by a very strong team from Canada in the Final. Under the guidance of Captain Lleyton Hewitt, the team performed stronger than most would have predicted. Having made it to the Final, Australia automatically qualifies for the 16 team 2023 Final Series commencing in September 2023.

The 2022-23 Australian tennis season kicked off on the 29th December with the inaugural edition of the United Cup. This event is an 18 team, mixed team competition, running over 11 days and played across three cites: Perth, Brisbane and Sydney. Each city hosted two groups of three countries, competing in a round robin format. Ties consisted of two ATP and two WTA singles matches and one mixed doubles match. The winner of each of the two groups played off in a City Final. The three City winners plus the best performed runner up advanced to a knock out event in Sydney. The Grand Final was played on Sunday 8th January. In the Round Robin competition Australia was grouped with Great Britain and Spain in Sydney and finished second in the group, losing to Great Britain and defeating Spain. The United States, Greece and Italy and Poland played off in the semi finals and the United States defeated Italy in the Grand Final. The Australian team of Alex De Minaur, Jason Kubler, John Peers, Maddison Inglis, Zoe Hives, Olivia Gadecki, and

Samantha Stosur performed admirably under the watchful eye of joint captains Lleyton Hewitt and Samantha Stosur.

The other International events over the summer included back to back WTA 500 and ATP 250 events in Adelaide, a WTA 250 event in Hobart followed by the Australian Open. Thanasi Kokkinakis performed well in Adelaide by following on from his 2022 victory with a semi final appearance. The hugely successful Australian Open saw Jason Kubler team up with Rinky Hijakata to win the Mens Doubles, while Alex De Minaur went down to the eventual winner Novak Djokovic in the 4th Round. Congratulations to Novak, winning his 10th Australian Open title and 22nd major title, tying Rafael Nadal's all time record.

Congratulations also to Aryna Sabalenka by taking out the Women's Singles event, her first major title. We are very pleased to note that under our new Agreement with Tennis Australia , Foundation members were able to access tickets to all of these events prior to public sales as well as access complimentary ground passes to the Open and tickets to the United Cup

In lieu of our annual Wimbledon High Tea event in July 2022 we were fortunate to join the International Tennis Club of Australia and friends and family of Frank Sedgman at Kooyong to celebrate the 70 year anniversary of Frank winning the Singles, Doubles and Mixed titles at the 1952 Wimbledon Championships. A magnificent achievement that has never been repeated and most likely never will.

In January 2023 we held our Australian Open lunch at Kooyong and honoured the legendary Neale Fraser, who after 51 years service to the Foundation, retired from the Board in September 2022. Neale's service to the Foundation, to Davis Cup and tennis in general has been remarkable and we could not have wished for a better function to honour his great achievements.

As we move away from the restrictions that have hampered overseas travel in recent years it remains a goal as part of our philosophy to support the up-and-coming new generation by helping to provide opportunities to participate in tournaments domestically as well as travel overseas to gain valuable experience. For this reason our financial contribution to Tennis Australia was directed towards a European Tour for 14 boys aged between 13 and 14 years old. We trust these boys benefited from the experience and that it puts them on the path towards international success.

Finally, I would like to acknowledge and share my appreciation to the Board of Directors for their significant contributions and guidance this past year. I am extremely grateful to Judy Pullyblank our Office Administrator, Robert Jamieson the Honorary Treasurer, Mary Klestadt for production of our eNews, web maintenance and communications and Trevor Dohnt for liaising with the office, organising events and preparing the Agendas and Minutes. The time and effort given is appreciated, not just by me but all in the Foundation. We are also grateful to Chris Brown and his team at Kooyong Tennis Club who play host to our Board meetings and various functions.



NEALE FRASER AO MBE — Retirement

In September 2022, Neale Fraser retired from the Board but fortunately for the Foundation he will remain as our Patron.

Neale was a founding member of the Foundation and for 48 of the 51 years of its existence, he held the position of either Vice-President or President. Neale's contribution to the Foundation has been the cornerstone of its success, not only as a result of his business acumen but also his strong links with the International Tennis Federation, Tennis

Australia and players who have represented our Country.

Apart from his valuable contribution to the Foundation, Neale was better known for his outstanding achievements as a player. As Tennis Australia notes on their website, he was a strong athlete known for his big forehand and fearsome lefty serve. A Wimbledon champion and dual US singles winner, he was unlucky to miss out on the Australian title, competing in three finals. In 1959 and again in 1960 he dominated the US championships, winning the singles, doubles and mixed titles in both years.

A committed Davis Cup player, he finished with an imposing 18 - 3 record. His commitment to Davis Cup continued for 24 years as captain. Neale guided Australian teams to victory in 1973, 1977, 1983 and 1986.

In 2008 he was awarded the ITF's highest accolade - the Philippe Chatrier award for outstanding achievement in tennis.

On behalf of all of the members of the Foundation, we thank Neale for his magnificent contribution to the Foundation, to the Davis Cup competition and tennis in general.

2022 Competition

Australia competed in the qualifying competition in Hamburg in September 2022 and finished in second place in their group, thus qualifying for the finals.



The finals were played in Malaga, Spain, from 22 - 27 November 2022.

2023 Competition

As a result of making the Final in 2022, Australia did not have to go through the qualifying rounds in February 2023 to be eligible for the 16 teams left to compete for the 2023 title.

The 16 teams have been placed in four groups of four and Australia will compete in September in Manchester, against the host Great Britain, Switzerland and France.

Two teams from each group will compete in a knock out Final competition in Malaga, Spain in November, 2023.



UNITED CUP 2023

The 2023 United Cup, replacing the ATP Cup, was an 18-team, mixed-team competition. The 11-day tournament began on Dec. 29 2022 and was played across three cities, Sydney (Sydney Olympic Park Tennis Centre), Brisbane (Queensland Tennis Centre) and Perth (RAC Arena).

In the final the USA defeated Italy 4-0 in the final played at Ken Rosewall Arena.

NOTES TO AND FORMING PART OF THE ACCOUNTS FOR THE YEAR ENDED 30th JUNE, 2023

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of preparation

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards, Australian Accounting Interpretations, other authoritative pronouncements of the Australian Accounting Standards Board and the Corporations Act 2001.

Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated

The financial statements have been prepared on an accruals basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected noncurrent assets, financial assets and financial liabilities.

(a) REVENUE AND EXPENDITURE

The Company recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the entity and specific criteria have been met for each of the Company's activities as discussed below.

Generally the timing of the payment for sale of goods and rendering of services corresponds closely to the timing of satisfaction of the performance obligations, however where there is a difference, it will result in the recognition of a receivable, contract asset or contract liability.

Revenue is recognised on a basis that reflects the transfer of promised goods or services to customers at an amount that reflects the consideration the Company expects to receive in exchange for those goods or services.

Donations and bequests are recognised as revenue when received.

Interest revenue is recognised when it becomes receivable on a proportional basis taking into account the interest rates applicable to the financial assets.

Other income is recognised on an accruals basis when performance obligations are satisfied.

All revenue is stated net of the amount of goods and services tax (GST).

(b) INCOME TAX

No provision for income tax has been raised as the entity is self-assessed as eligible for Income Tax Exemption (ITE) as set out in the ATO Income Tax Guide for non-profit organisations.

(c) CASH AND CASH EQUIVALENTS

Cash and cash equivalents include cash on hand, deposits held at call with banks and other short-term highly liquid investments with original maturities of twelve months or less.

(d) GOODS AND SERVICES TAX (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

(e) ACCOUNTS PAYABLE AND OTHER PAYABLES

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the company during the reporting period which remain unpaid. The balance is recognised as a current liability.

(f) FINANCIAL ASSETS

All recognised financial assets are measured in their entirety at fair value.

Classification

On initial recognition, the Company classifies its financial assets into the following category, those measured at:

- fair value through profit or loss - FVTPL

Financial assets are not reclassified subsequent to their initial recognition unless the Company changes its business model for managing financial assets.

Financial assets through profit or loss

All financial assets not classified as measured at amortised cost or fair value through other comprehensive income as described above are measured at FVTPL.

Net gains or losses, including any interest or dividend income are recognised in profit or loss.

The Company's financial assets measured at FVTPL comprise listed investments over which they do not have significant influence nor control.

(g) EMPLOYEE BENEFITS

Provision is made for the company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

Contributions are made by the Company to an employee superannuation fund and are charged as expenses when incurred.

(h) ADOPTION OF NEW AND REVISED ACCOUNTING STANDARDS

During the current year, the Company adopted all of the new and revised Australian Accounting Standards and Interpretations applicable to its operations which became mandatory. The adoption of these Standards has not had a significant impact on the recognition, measurement and disclosure of transactions.

(i) NEW ACCOUNTING STANDARDS FOR APPLICATION IN FUTURE PERIODS

The AASB has issued new and amended Accounting Standards and Interpretations that have mandatory application dates for future reporting periods. The company has decided against early adoption of these Standards but does not expect the adoption of these standards to have any significant impact on the reported position or performance of the Company.

NOTE 2: RELATED PARTY TRANSACTIONS

No transactions between related parties were conducted save for services provided by directors at no fee.

NOTE 3 EVENTS OCCURRING AFTER THE REPORTING DATE

The financial report was authorised for issue on 1 September 2023 by the Directors.
